

Ministry failed to prepare service structure for doctors, nurses: PMA

ISLAMABAD: Pakistan Medical Association (PMA) has criticised the federal health ministry over failing to formulate a service structure for thousands ofdoctors and nurses.

`PMA feels distressed over the irresponsible attitude of the federal health ministry for failing to formulate a service structure for thousands of its employees at five hospitals in Islamabad and Rawalpindi, even after the passage of 30 years.

Due to this negligence, these employees have been reverted to their basic pay scale,` according to a statement issued.

`The finance division in 1991, without any service structure, decided to upgrade the pay grade of these medical professionals, after time scale, and hence these employees were placed in BPS-18, BPS-19 and BPS-20. However, now the Accountant General of Pakistan Revenue (AGPR) has downeraded the uav scale and also decidedo recover the additional money paid to hospital staffers without any promotion in the absence of the service structure, ` it stated.

`This is very unfortunate that health professionals are facing trouble and mental torture due to the carelessness of health ministry. Some of these employees at their retirement are reverting from BPS-20 to BPS-17. Now such cases of BPS-20 are being prepared for retirement benefits as an officer of BPS-17,` it stated.`This is what we are awarding health professionals, at their retirement, after their laborious services to the nation. This is unjustified and PMA demands from the government to immediately take notice of the situation and formulate service structure at its earliest to provide due rights and justice to all such health workers,` it stated.

PMA Secretary General Dr Abdul Ghafoor Shoro, while talking to Dawn, said that it was unfortunate that health professionals were suffering.

`We were at the frontline during Covid-19 and sacrificed lives of a number of doctors and nurses. On the other hand issues related to medical fraternity have been put on the back burner,` he said. Staff Reporter
